TERMS & CONDITIONS

- 1. Tenders must be submitted on the prescribed form issued by the Corporation and must be accompanied by earnest money @ Rs. 1,00,000 (one lac. only) for the supply of 1,00,000 each B.Twill gunny bags for packing 50kg. wheat in this etender through online mode only, mentioning transaction, No. UTR No to be deposited in favor of "PUNJAB STATE SEEDS CORPORATION LTD. MOHALI. The tenders not submitted on prescribed form or without prescribed amount of earnest money or without earnest money in any other form, shall be summarily rejected.
- The earnest money of the unsuccessful tenderers will be refunded after the finalization of the tender(s). The successful tenderer(s) shall be required to deposit security amount equal to 10% of the value of order through bank draft in favor of the Corporation payable at Mohali or in form of bank guarantee within 7 days from the date of the supply order. The successful tenderer have to submit his offer letter to corporation for the inspection of total quantity given in tender within three days after receipt of the supply order. No interest will be payable on earnest money or on security deposits.
- 3. Where for any unavoidable reasons the tenders cannot be opened on the date prescribed in the tender, the date shall be extended and such extended date will be notified in the Corrigendum. In case, the specified date of opening falls on a holiday or a holiday is subsequently declared on that date, the tenders will be opened on the next working day following holiday(s).
- 4. The rates of the material should be quoted both in figures and words and there should not be any over writing. Corrections, if any, should be duly signed by the tenderers. Rates should be quoted F.O.R. destinations as desired and should be inclusive of charges of packing, loading, freight, octroi, unloading charges, inspection charges, testing charges and the statutory levies like CST/ST/excise duty/VAT/GST and other taxes, fee, cesses etc which ever applicable. Any tax liability up to delivery points on material will be borne by the supplier. The tenderer must also mention PAN/TIN/GST No. of the firm.
- 5. In case it is observed that the prices offered are on higher side than the normal expected price or due to any other reason, if felt necessary, negotiations with the L-1 may be carried out with the tenderer(s) or their authorized representative(s).
- 6. The contract for the supply shall be deemed to have come into existence from the date of issuing of supply order and all causes of action in relation to the contract will therefore, deemed to have arisen within the jurisdiction of the Mohali courts.
- 7. The quantity mentioned in the NIT/Tender form may be decreased or increased at the sole discretion of the Corporation.
- 8. The delivery schedule mentioned in tender form/ supply order of the Corporation will be final and binding on the tendering firm/supplier.

Person or persons signing the terms & conditions shall state in what capacity he 9. or they are signing the tender.

In case of partnership firm, the names of all the partners should be disclosed and the terms & conditions should be signed by all the partners or their attorney 10. having authority to bind all the partners in all the matter pertaining to the contract including the Arbitration clause.

In case of a private limited company, the names of all the directors shall be 11. mentioned and it shall be certified that the person signing the terms & conditions

is empowered to do so on behalf of the Company.

The person signing the terms & conditions or any document forming part thereof 12. on behalf of another or on behalf of a firm shall be responsible to produce a proper power of attorney duly executed in his favor stating that he has authority to bind such other persons or the firms as the case may be in all matters pertaining to the contract including the Arbitration clause.

The tenderer must enclose the proof of performance certificate for the 13. successful supply to Govt. organization /private parties during the last three

years if any.

The tenderer may enclose the proof of list of Govt. buyers if any to whom the 14. material was supplied earlier.

Any tender for less than the tendered quantity shall be rejected. 15.

In the event of any breach of any terms & conditions of the contract, Punseed 16. shall have the right to withheld earnest money and security deposit and such amount would stand forfeited without any notice to the supplier/tenderer.

The Managing Director, Punseed reserves the right to reject all or any of the 17.

tenderer rates/bid/tender without assigning any reason thereof.

The suppliers who have defaulted in faithful execution of supply order in the past 18. need not apply as they shall not be considered at all. The decision of the Managing Director of the Corporation in this regard will be final.

In case of non supply /defective/short/delayed supplies, the Corporation shall be entitled at its sole discretion to impose penalty. Purchase will be done at the risk 19. and cost of the tenderer and take other measure(s) as may be deemed necessary including cancellation of the contract. Any extra expenditure incurred on such purchase shall be recoverable in full from the tenderer without prejudice to any other right of the Corporation including right of claim for liquidated damages.

The time allowed for delivery will be essence of the supply order. In case of delay in execution of the order, the Corporation may cancel the order without 20. any compensation and the supplier may be liable to a penalty subject to a maximum of 15% and the same shall be recoverable either from the earnest money/security or from the pending bills of the supplier or from any other deposits /securities etc. lying with the Corporation or through a court of law as the case may be. The decision of the Managing Director of the Corporation in this behalf shall be final and binding on the tenderer. Supplies/consignments received after the date on which they were actually due (according to the terms of the Purchase supply Order) will be liable to be rejected by the corporation. In case the purchasing authority decides to accept a delayed supply, the supplier may still remain liable to pay a penalty for the delay as mentioned hereunder:-

However Managing Director, Punseed keeping in view the circumstances or losses caused by delayed supply shall be competent to waive off penalty. Moreover, the time relaxation in the dispatch of any material will be given by Managing Director.

- 21. If the material is dispatched by the supplier after the expiry of the delivery period, without any approval of the purchasing authority/Managing Director, such a supply will be liability of the supplier and will be at his own risk.
- 22. a) The supplier shall be bound by communication of acceptances dispatched within a period of 3 days from the date of the supply order.
 - b) The validity of tender will be for a period of one year from the date of placing the supply order.
 - c) The Corporation reserves its right to place a repeat supply order as per the requirement on the same terms and conditions as those of previous supply order/e-tender.
 - d) Rates: The rates should be quoted for the offered items on the basis of FOR ie. upto the offices of the Punseed located at different destinations in Punjab and inclusive of all taxes i.e. GST, Duties, packing forward charges loading/unloading etc.
- 23. **Delivery Schedule** Bags should be offered by the supplier for inspection and sampling as under:-

Supply of 50% bags must be completed within 10 days from the date of the supply order and the remaining 50% within 20days from the date of supply order. Supplies must be completed within 20 days from the date of supply order at each destination.

24. INSPECTION & SAMPING

Inspection and sampling of B.Twill Gunny bags will be carried out in the premises of the party or at PUNSEED processing plants by representatives of the Corporation or by the inspection agency appointed by Managing Director. The representative of the Corporation or agency will draw the samples in the presence of the supplier/representative (s) and the samples will be tested at any Govt. approved test house of the choice of the Corporation to ascertain that the

material meets the standard /specification fixed in the e-tender. The material should be dispatched to the consignee as per delivery schedule and order of Managing Director. The cost of inspection, verification and testing charges will be borne by the supplier and if for any reason, more than one inspection /test are to be carried out, the cost of subsequent inspection/test will also be borne by the supplier.

- 25. Payment: The payment of the supplier will be made by the Head Office of the Corporation and for this purpose, the bills in triplicate, GR, a copy of the Inspection Report should be sent by the concerned Regional Manager/Incharge with a copy to the Head Office for 80% payment and the payment will be released after the material actually reaches at destination in good condition and as per terms of the supply order. The balance payment will be made after full execution of the purchase order to the entire satisfaction of the Corporation as per Corporation's terms and condition. The remaining 20% payment will also be released from the Head office after actual receipt of the material at site/Punseed offices in good condition. For this purpose also Regional Manager/Incharge will receive the goods and immediately send the GR with a certificate that the material is received in good condition and as per the purchase/ supply order.
- Packing cases, containers, gunny package etc. which may be used for purpose of packing by the supplier and which are delivered to processing plants/offices will not be returned to supplier and no charges will be given by the corporation of that material.
- 27) In the event of any dispute arising out of the contract/tender, the Managing Director, PUNSEED or his nomine shall be the Arbitrator, whose decision shall be final and binding on both the parties.
- 28) No force Majure clause will be applicable.
- Two samples of B.Twill Gunny bags without any marking and printing of givens specifications should be submitted to PUNSEED Head office as a sample on or before 21/03/2024. The sample conforming the mentioned specification as mentioned in etender for which the rates are quoted by the tenderer should mandatory be submitted to PUNSEED, Head Office, Phase -6, Mohali in a closed envelope with seal, address and stamp of tenderer on it. Moreover the samples received from the tenderer to Punseed may be sent to laboratory test Purpose. The test report received by the laboratory shall be final binding on the tenderer/supplier. In the absence of submitting the samples to the PUNSEED Head Office, Mohali Managing Director of PUNSEED reserve the right to reject the rate quoted by that supplier/tenderer and may not be considered eligible for the further tendering process i.e Technical and Financial bid. Punseed reserves the right to send any samples for laboratory test purpose. - will be further considered for financial bid. The decision of the M.D in above said regard will be final and binding on the tenderer/supplier/bidder.
- In case the material supplied found inferior in quality standard then in that case M.D PUNSEED reserves the right to impose quality cut charges to the party/supplier. The decision shall be final and binding on the party/supplier.
- 31) The quantity mentioned in the e-tender may increase or decrease.
- B.Twill gunny bags 50kg. will be supplied in uniform packing bales. Bales will be wrapped in ordinary, Hessian cloth securely tightened with iron-strips or with any other material so that they do not get loose during transit.
- 33) Bid without payment of Tender cost & EMD shall be liable for rejection, However, MSMEs registered with NSIC are exempted from payment of cost of tender document and EMD subject to furnish valid documentary proof in support of claim along with the request letter.
- 34) PUNSEED reserves the right to accept or reject any or all tenders without assigning any reason thereof.
- 35) The tenderers are advised in their own interest to carefully read the tender documents and understand their purport unless the tenderer specifically states to the contrary in respect of any particular clause, it shall be presumed that tenderer accepts all the terms and conditions as have been laid down in the tender document.
- 36) The tenderer have to supply 100% quantity mentioned in this tender.
- 37) Printing material on bags will be given at the time of supply order.
- 38) All pages of the tender should be signed and stamped by the tenderer.
- 39) The Earnest money will be forfeited if the tenderer withdraws price bid or in case of a successful tenderer fails to pursue as per the tender terms and conditions/non fulfilling the supply order/ not deposit security deposits as per the tender terms and conditions.
